Where to start?



- ▶ CTE is really a blanket term for a number of program models and educational outcomes. So, it's important to clearly identify from the start why you want to implement CTE in your district and what goals you hope to achieve through your program.
 - ▶ Are your classes geared toward flexible on-line career programming example 180 Skills
 - ▶ Are your classes hands on that need to be on-site at a Technical Center? Example-welding, HVAC, CENA
 - ▶ Are your classes at your school with a room created for training? Example Medical Assistance, Call Center

Who is eligible?



Federal - WIOA

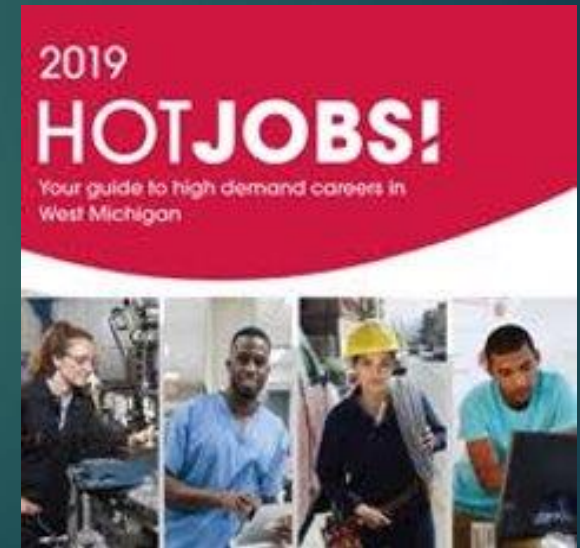
- ▶ An individual must be 18 years of age or older, a U.S. citizen or eligible non-citizen and registered with Selective Service (if applicable) to receive services under the dislocated worker program. Participant eligibility is also dependent upon also dependent upon:
- ▶ Has been terminated or laid off, or who has received a notice of termination or layoff, and
- ▶ Is eligible for or has exhausted entitlement to unemployment compensation; or
- ▶ Has been employed for a duration sufficient to demonstrate attachment to the workforce, but is not eligible for unemployment compensation; and
- ▶ Is unlikely to return to a previous industry or occupation; or
- ▶ Has been terminated or laid off, or has received a notice of termination or layoff, from employment as a result of any permanent closure of, or any substantial layoff at, a plant, facility, or enterprise; or
- ▶ Is employed at a facility at which the employer has made a general announcement that such facility will close within 180 days; or
- ▶ Is employed at a facility at which the employer has made a general announcement that such facility will close; or
- ▶ Was self-employed but is unemployed as a result of general economic conditions; or
- ▶ Is a displaced homemaker.

State – Section 107 Special Programs

- ▶ Enrolled House Bill 4242 (Public Act 58 of 2019) reflects the following:
- ▶ Eligibility - Section 107(3):
- ▶ ...the individual must be at least 18 years of age and the individual's graduating class must have graduated.
- ▶ The State's definition remains the same as last year: An individual is eligible July 1 after the individual's 18th birthday.
- ▶ Special Programs - Section 107(15):
- ▶ The language remained the same as last year and did not include the proposed language requiring an individual to be actively working toward obtaining a high school diploma or a high school equivalency certificate.
- ▶ The State's policy remains the same as last year: Grant recipients are required to adhere to the intent of the grant, which is to primarily serve adult education participants who are actively working toward earning a high school diploma or a high school equivalency certificate.

Offerings

- ▶ Stay in tune to the skills that are most in demand across industries and make sure that you know which skills and careers are getting participants excited—and keep in mind that both are going to change over time not only your curriculum but needs.
 - ▶ Manufacturing
 - ▶ Hospitality
 - ▶ Health care
 - ▶ IT



Staffing

- ▶ Do you have the right person who loves to create curriculum?
- ▶ Do you have the right person who loves to be innovative?
- ▶ Do you have the right person who has the skills to integrate HSE or CCRS or ESL into the curriculum?
- ▶ Do you have someone who knows the skills (qualified) you want them to teach?



Funding-Funding-Funding!



- ▶ Funding is a key issue with any type of training.
- ▶ Ways to get funding:
 - ▶ Michigan Works! Build that relationship with classes that you have created and credentials or job placement promises
 - ▶ Grants-many are out there that allow you to use for training or are specific to a training-example construction....
 - ▶ MCTI – Michigan Career & Technical Institute
- ▶ WIOA funding-allows you to use 20% on training dollars
- ▶ Section 107 Special Programs Grant – 10 programs statewide
